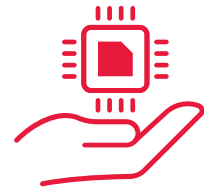

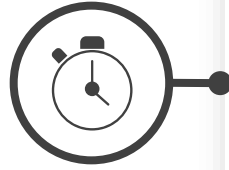

AI BENEFITS

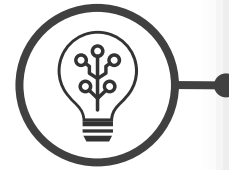
- ▶ AI has the potential to bring numerous benefits to businesses and society.

AI CHALLENGES

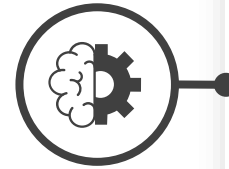
- ▶ There are several challenges associated with the development and deployment of AI systems.

Time-saving: Provide quick and accurate answers to questions, eliminating the need for extensive research.



Idea generation: Generate ideas and offer suggestions for various tasks, such as brainstorming sessions or creative projects.



Language assistance: Assist with language-related tasks, such as proofreading, grammar suggestions, and language translation.

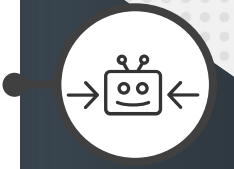
Learning and education: Serve as an educational resource, providing explanations, examples, and practice opportunities.



Task automation: Can automate some simple tasks, such as generating code snippets or providing basic information.



Virtual assistance: Act as a virtual assistant, helping with basic tasks like setting reminders, making to-do lists, or providing weather updates.



Driving Artificial Intelligence Responsibly

GOVERNANCE FOR RESPONSIBLE AI

AI Governance is a set of policies, frameworks, tools and practices which guide the selection, development, deployment and use of AI systems. The goal of AI Governance is to ensure that these technologies are used in a responsible and ethical manner, while maximizing the benefits and minimizing potential risks. Effectively governing AI requires engagement and collaboration between multiple stakeholders, including legal, privacy, compliance, technology, and business leaders.



Grow AI with a Cyber Foundation

Artificial Intelligence deployments are fundamentally applications with some new/adjusted components.

- ▶ Ensure resilience of the data sources and/or the compute/model
- ▶ How do you address training/model development and protection?
- ▶ Affirmatively support privacy controls and monitor insider risk
- ▶ Manage/secure the posture of cloud services used to operate and/or consume AI products

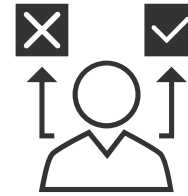

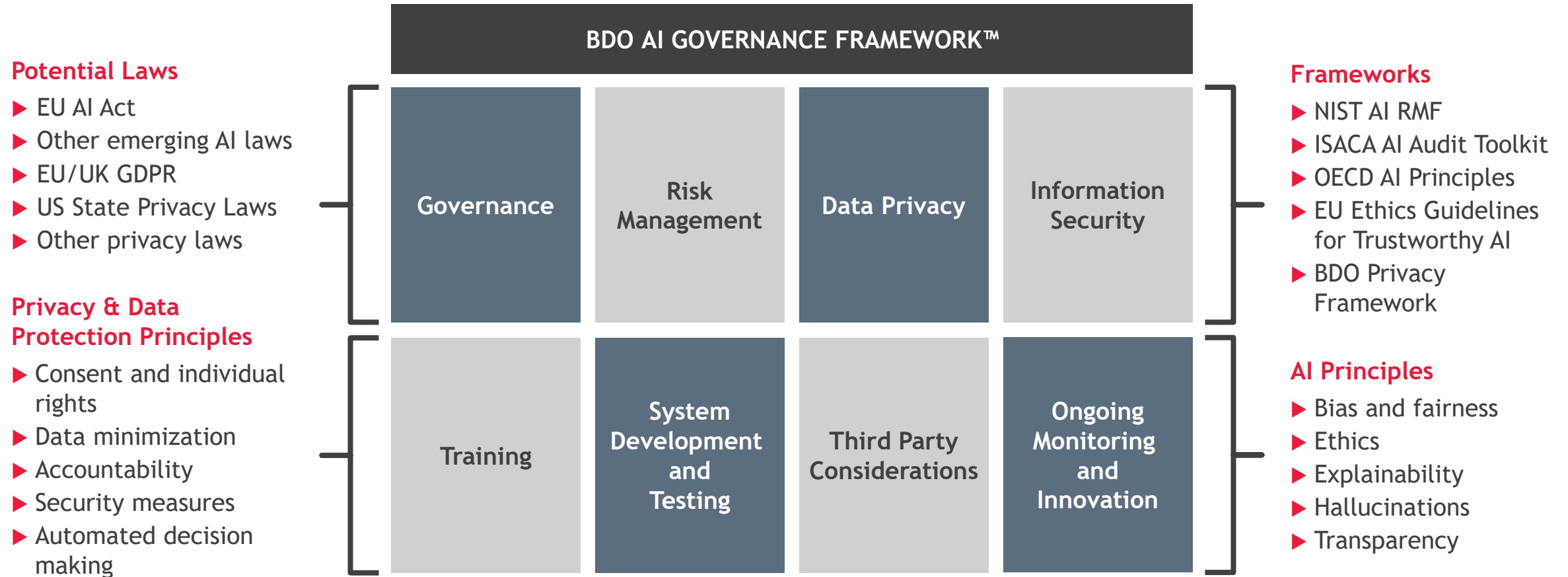

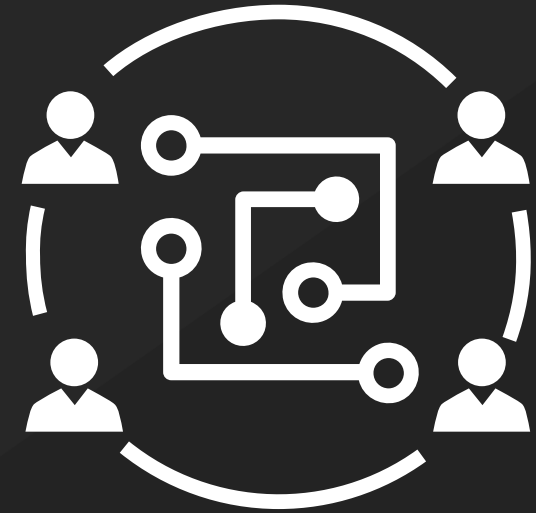
