# BEST PRACTICES FOR MANAGING FEDERAL FUNDING FOR BIODEFENSE

Receiving a federal award is exciting and opens many doors for product developers. However, these awards have strict regulatory and compliance requirements to ensure taxpayer money is spent appropriately. This is especially true in the biodefense space, where products and technologies are intended to ensure the safety of both U.S. civilians and military personnel. These best practices provide a solid foundation on which to build your federal award management strategy and remain compliant with the broad array of requirements.

# **Best Practices for Managing a Federal Award**

Communicate actively with the government.



You'll submit monthly reports to the government, but your communication responsibilities don't stop there. The government should be notified of any adjustments to scheduling, performance or budget as soon as possible. There should never be any surprises in your monthly reports.

Establish a purchasing policy.



It's your responsibility to make sure the prices you're paying are fair and reasonable. Always maintain proper, written documentation of all purchases and design a policy that meets the basic requirements of federal awards to ensure you are remaining compliant.

Put everything in writing.



When it comes to managing federal funding, accurate documentation is everything. Make sure you have everything in writing from the government, including technical directives. This will make it much easier to fulfill your reporting requirements and reduce the risk of miscommunication.

Never incur costs without consent.



You must have the proper approvals and systems in place before you begin to incur costs. Failure to do so may put your reimbursement of those costs in jeopardy. Ensure you are aware of the terms required by your federal awards prior to incurring costs.

Design a **project** accounting system.



The goal of your accounting system should be to track and account for all project costs. Your accounting system must meet not only basic Generally Accepted Accounting Principles (GAAP) but also the unique federal cost accounting requirements and your award-specific terms.

Create a robust data governance process.



If you've received federal funding related to biodefense, chances are you'll be working with sensitive information. Regardless of the type of information you collect and use, you should always be confident in your ability to secure and protect your data. Proper management of your federal awards is key to ensuring the successful development of your product or technology. It can open the door for additional funding to support later stage development, or to new partnerships for the development of additional products and technologies. However, if you mismanage your award, you could be responsible for the financial fallout and it may damage your ability to work with the government in the future. It's crucial to keep careful documentation and build robust processes to ensure you're remaining compliant and satisfying your obligations.
